



Policies for Reopening Bolton Street Synagogue COVID-19 November 2020

Decisions about re-opening our indoor and outdoor spaces for services and other communal activities will be based on national and local data, on recommendations from State and local sources, and on the advice of our own Coronavirus Prevention Task Force of medical and epidemiological experts.

Indoor Shabbat Services and meetings will continue on Zoom and Facebook Live at this time.

The following guidance is intended to help ensure the safety of our congregants and guests.

Outdoor Services/Events

Symptoms:

Those who have experienced any of the following symptoms in the 48 hours preceding an outdoor service/event: fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, may not attend an outdoor BSS service/event.

Those who have been in close physical contact, in the last 14 days preceding an outdoor service/event with a person who is known to have laboratory-confirmed COVID-19 or with anyone who has any symptoms consistent with COVID-19, may not attend an outdoor BSS service/event. *Close physical contact is described as- within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period starting from 2 days before

illness onset (or, for asymptomatic patients, 2 days prior to test specimen collection) until the time the patient is isolated.

Those who are isolating or quarantining because they may have been exposed to a person with COVID-19 or are worried that they may be sick with COVID-19, may not attend an outdoor BSS service/event.

Those who are at risk because of an underlying health issue or who are 60 years of age or older are strongly encouraged, for their own health, to avoid the risk of attending public celebrations at the synagogue until all restrictions have been lifted. Any such person attending assumes some personal risk.

Restrictions:

- Attendance for outdoor services/events will be **limited to 20 participants**, plus the rabbi and an usher.
- When leading from the pulpit, the rabbi, cantor, Bar/Bat Mitzvah, or congregant can take off their mask. **Masks must be worn by all others who are not leading the service** including children ages 3 and older. Masks must cover the mouth and nose.
- **Only the rabbi and the Bar/Bat Mitzvah student may sing or chant during outdoor services.**
- The Torah scroll will be handled only by the rabbi or by the B'nai Mitzvah family.
- The BSS building will be closed during outdoor services/events. Use of restrooms will only be allowed for emergencies, and all safety protocols, including mask wearing and social distancing, will apply in the restrooms.
- While at Bolton Street outdoor services and events, individuals/families are to maintain **at least 6 feet** between themselves and other individuals/families. Ushers will help to manage appropriate distancing. Because small children might find it difficult to maintain physical distancing, parents should consider whether to bring them to services/events where physical distancing is required.
- No Oneg Shabbat, Kiddush or any food or drink will be served.
- The use of Zoom, Facebook Live, or other streaming service will continue so that those who can't be physically present will be able to participate remotely.

Check-In/Arrival/Dismissal Procedures

- Congregants and guests are asked to arrive in the front parking lot 15 minutes prior to outdoor services/events in order to check in and to be directed by ushers.

- Congregants and guests **must check in at the BSS COVID screening table** upon arrival where they will be required to take their temperatures, answer screening questions and use hand sanitizer.
- Ushers will seat congregants, guests and families **at least 6-feet apart**.
- Please no handshakes or hugging. **Social distancing is required.**
- **Congregants may not gather on the premises after services.**

Synagogue Procedures

- **At least one usher (staff member or volunteer) must be present** while an outdoor service/event is taking place to enforce compliance with the gathering restrictions and hygiene protocols.
- Hand sanitizer and face masks will be available in easy-to-access locations.
- The Bolton Street Synagogue restrooms and greater building will be kept clean and sanitized.
- Seating areas will be clearly marked to indicate where people can sit/stand while meeting physical distancing requirements.

***Bolton Street Synagogue reserves the right to cancel an outdoor service/event in the case of heightened and significant COVID risk, based on the recommendations of Baltimore City, the State of Maryland, and the BSS COVID Task Force.**
